

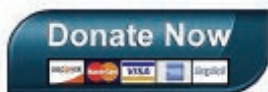

Altrusa Foundation Day of Giving June 20th, 2020

The Covid-19 epidemic has impacted the Altrusa International Foundation programs by causing the canceling of all District Conferences, except one.

The conferences are the primary fundraisers for the Foundation.

In response, the Board of Trustees declared June 20th to be "ALTRUSA INTERNATIONAL FOUNDATION DAY of GIVING".

DISASTER RELIEF DISTRIBUTION 2019-2020

- » \$8,788 for solar-powered Luci lights to the following organizations:
 - » 300 lights to Altrusa International of District Fourteen (Puerto Rico)
 - » 300 lights to Medicine For Mali
 - » 150 lights to the Ghana Health & Education Initiative
- » \$2,160 for 160 Luci lights with USB ports to District Fourteen
- » \$1,000 to Douglas County Community Foundation after tornadoes in District Eight
- » \$1,000 to Network of Community Ministries after tornadoes in District Nine
- » \$1,000 to Pathways of Hope for Covid-19 basic supplies and rental assistance in District Eleven
- » \$1,000 to the Foodbank of Santa Barbara County for Covid-19 support in District Eleven
- » \$1,000 to the 5Cities Homeless Coalition for Covid-19 shelter support in District Eleven
- » \$1,000 to Maskeraiders to make masks for Covid-19 support in District Eleven
- » \$1,000 to GlobalGiving focused on supporting those displaced after wildfires in Australia



The Australia Wildfires Relief Fund immediately provided food, fuel, clean water, hygiene products, and shelter to survivors impacted by the disaster.

In the month of April, the 5Cities Homeless Coalition prevented the eviction of eight families, and helped house four, who were affected by Covid-19

GRANTS PROGRAM EARLY CYCLE ONE DISTRIBUTION OCTOBER 30TH, 2020

The Foundation Board of Trustees are committed to serving our communities by meeting the needs of those left in the wake of Covid-19.

To best support Altrusans in service, the Grants Committee agreed to distribute the next cycle of funding one month earlier on October 30th, 2020. The purpose is to fund projects without delay.

Through the Grants Program, the Foundation provides vocational assistance to individuals, and helps Altrusa Clubs carry out independent programs of service with funds for literacy, abused and battered women, aged, homeless, handicapped, underprivileged children, underprivileged children requiring medical attention, disadvantaged community members, and active military or veterans.

All applications received are confirmed via email to the contact person listed on the application.

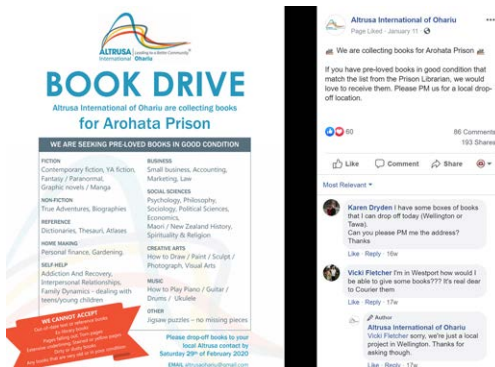
Spotlight an Altrusa Club

ALTRUSA INTERNATIONAL CLUB OF OHARIU, NEW ZEALAND

Little did the Altrusans of Ohariu, New Zealand know when they formed their club 18 months ago that their first literacy project in the community would go viral in a Facebook post.

“Our club knew our project would focus on literacy as a key principle of Altrusa. We found a need for books in undersourced schools and the local women’s prison. Since we wanted to empower readers, and we’re active in the technology community, we chose to focus on ‘girls who tech,’” said Katrina Clokie, of the Ohariu Club.

The Facebook post asking for book donations to the local women’s prison went viral with 193 shares and over 40,000 views.



The 2019 literacy project called *Get Set For A Brighter Future* received a grant from the Altrusa International Foundation, Inc. The timing couldn’t have been better. The librarian at the women’s prison said they just started a new book club and were in need of book sets. Later, in early 2020, the librarian shared a wish list from inmates that resulted in the viral Facebook post. The Ohariu Club received thousands of books they’re still distributing today.

“The *Girls Who Code* tech books were distributed to 23 local primary schools. We also were able to give a primary school instructional readers to support early learning,” said Katrina. “It was really cool to fulfill the educators’ wishlists when funding wasn’t going to stretch that far for them.”

Additional funding came from a nonprofit organization called WeTest that was founded by Katrina and a couple local colleagues. When the organization dissolved it distributed \$10,000 to the Ohariu Club’s technology education service projects.

The Ohariu Club members spent about 40 hours on the project between sticking books with the Altrusa logo, delivering the books, and organizing book drives.

“Everything that’s been contributed is being used. We are looking forward to the relationships forged in this project with our local educators and librarians to support the futures of all our readers.” Katrina said.

- » Chaired an Altrusan project or program (not a fundraiser)-they may have chaired a project sponsored in cooperation with another civic or charitable organization

- » Is a true volunteer, not a paid staff member
- » Does not have to be a Altrusa member

There may be (1) nomination per Altrusa Club.

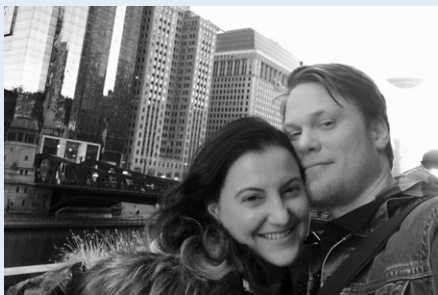
The Anna H. Settle Community Leadership Award will be presented at the Altrusa International Convention in Quebec City.

HOW TO SERVE ON THE ALTRUSA INTERNATIONAL FOUNDATION, INC. BOARD OF TRUSTEES

Three new Foundation Trustees will be elected at the Quebec Convention in July 2021. The districts eligible to slate potential Foundation Trustees at this Convention are Districts Two, Three, Four, Five, Seven, Eight, Ten, Twelve, Fourteen, and Fifteen. It is up to each district to determine how its nominee shall be selected.

The candidate for Trustee must be an active member in good standing of an Altrusa Club. They must have current or prior experience with a charitable corporation or foundation, serving in an elected or appointed position with policy-making responsibility. They must have served a full term as president of an Altrusa Club or Local Club Foundation. During all or part of the term for Trustee for which the candidate is standing for election, the candidate must not serve in any capacity for Altrusa International, Inc.

The role of a Trustee is to support the mission of the Foundation. The responsibilities include promoting programs to members of Altrusa and the public by communicating program services, cultivating prospects and potential donors of the Foundation, writing articles, helping to lead Convention workshops, and assisting in the biennial fundraisers, among other things. The Trustee term is four years, except the Immediate Past Foundation Chair and Finance Chair serve an additional two years.

Trustees may choose to serve on any of the following:

- » Anna H. Settle Community Leadership Award Committee
- » Education, Development & Marketing Committee
- » Finance Committee
- » Grants Committee

If you're interested in serving on the Foundation Board of Trustees, please contact your District Governor for your nomination to be submitted to the Foundation office.

The 2021 Foundation nominees are due to the Foundation office by January 8th, 2021
